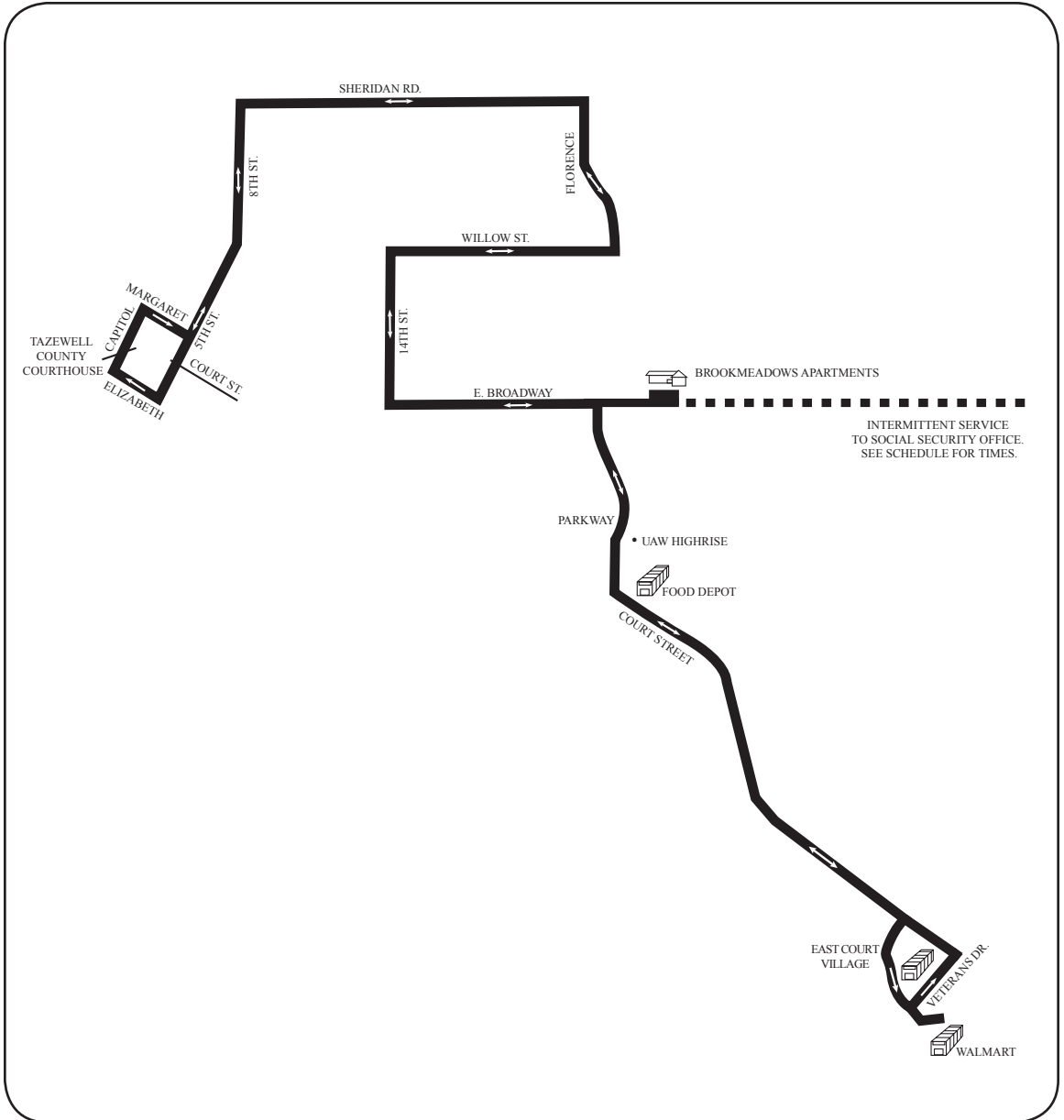

**All Seniors (65 & older) pay 50¢ per ride.**

## SENIORS ages 65 and older ride for \$0.50 each ride

Effective January 1, 2016, Seniors (age 65 and older) pay \$0.50 CASH FARE for each ride. There are no longer different fares for seniors between PEAK and NON-PEAK times; and free rides for seniors during NON-PEAK times have been eliminated.

To be eligible for the \$0.50 CASH FARE, Seniors must present a valid Medicare card, State ID, or CityLink Half-Fare ID card.

Transfers were also discontinued so passengers have to pay a cash fare for each ride, unless they are using a Day Pass or a 30-Day Pass, which provide unlimited rides (discounts are not provided for these passes.)

This change is more convenient for Senior passengers, reduces confusion and opportunities for conflicts with operators. Benefit Access RIDE FREE program is available for eligible Senior residents of Illinois. Contact the Central Illinois Agency on Aging at (309) 674-2017 for more information.
