1	Clarifications: (page 18, Section 2-3) 2.3 Fluids in Quart Sizes: <ul style="list-style-type: none">• 5W20 Conventional Motor Oil• 5W30 Conventional Motor Oil	<i>GPMTD modifies the following:</i> <ul style="list-style-type: none">• <i>5W20 Synthetic Blend Motor Oil</i>• <i>5W30 Synthetic Blend Motor Oil</i> <i>5W20 and 5W30 should be Synthetic Blend.</i> <i>5W20 and 5W30 should be in Quart sizes.</i>
2	Clarification: Section 2-4 Pricing – Bulk Fluids (page 18) “Price detail should be listed as the Markup fee the Vendor’s charge and any freight costs. Each specified bulk fluid should be listed separately with applicable Mark-up fee and any freight costs.” Section 3-9 Pricing, Taxes and Effective Date: 2 nd paragraph: (page 22) “Price Bids shall include all freight charges, FOB to the designated delivery points.”	<i>Section 2-4 and Section 3-9 as listed shall be replaced with:</i> <i>“Price detail for each product should be listed separately with the applicable Markup (Vendor charge). All related freight charges shall be FOB to designated delivery point.”</i> <i>GPMTD will not pay freight as a separate charge.</i>
3	Can you provide me with monthly volumes of your 15W40 and TES-295?	<i>15W40 – 1,465 Quarts per Month (Average)</i> <i>TES 295 – 185 Quarts per Month (Average)</i>

4	Who owns the bulk fluid totes for 15W40, TES-295 and Windshield Washer Fluid/Anti-Freeze?	<i>Vendor owns or will provide Totes for dispensing bulk fluid products.</i>
5	Who will supply the equipment for the totes, including hoses, digital dispensing nozzles, etc.	<i>Vendor will provide the equipment to dispense bulk fluids from the totes. Vendor will be responsible for maintaining equipment.</i>
6	Will GPMTD be performing sampling?	<i>Yes. GPMTD will be performing sample testing on products delivered.</i>
